# PIN 23-09-ASC END OF LIFE OPTION ACTS UPDATES

The EOLOA permits a mentally competent adult who has been diagnosed with a terminal illness by their attending physician (and verified by a consulting physician) to seek a medication for the purpose of ending their own life. The EOLOA created a process for submitting these requests and mandates that all oral and written requests for a medication that aids in dying be accompanied by particular documentation in the patient's medical file.



**Note:** In addition to the two oral requests, a valid written request must be signed and dated, in the presence of two witnesses, by the individual seeking the aid-in-dying drug. Only one of the two witnesses may:

# PIN 23-09-ASC END OF LIFE OPTION ACTS UPDATES

## PARTICIPATION BY YOUR CARE PROVIDERS

For moral, ethical, or other reasons, your care providers may decide not to participate in certain EOLOA-related activities. If a resident or prospective resident chooses not to participate in EOLOA-related activities, your care professionals may disclose this decision to them. Giving, dispensing, or giving the aid-in-dying medication are some examples of these tasks. Another is seeing the competent resident take the medication.

## RESIDENT RIGHTS

Even if your care providers do not want to be engaged, you have the right to get and use the aid-in-dying medication if you are eligible for it under the EOLOA. If you choose to utilize your rights under the EOLOA, you cannot be forced to leave the facility.

## MEDICATION STORAGE

You have two choices for keeping the aid-in-dying medication if you are eligible for it under the EOLOA:

- 1) centrally store it with the facility, or
- 2) keep it locked up and secure in your room.

You must store the medicine in a lockable container that prevents others from obtaining it if you decide to keep it in your room. It's crucial to bear in mind that, even in cases where the facility has a policy requiring medicine to be kept centrally, you still have the option to store the medication in a lockable container in your own room. Your care providers must comply with your request to have the medicine kept centrally if the facility stores and handles prescriptions, unless the facility opposes to being involved in EOLOA-related activities.

You are in charge of keeping the drug in a secured container in your room or off-site at a loved one's house if your facility refuses to participate in the EOLOA activities.

## RESIDENT DISCLOSURES

You do not have to disclose your intentions to your care providers if you are considering utilizing the EOLOA or if you are eligible for the aid-in-dying medication. It is a good idea, nevertheless, to discuss your end-of-life arrangements with your care providers. Doctors also have to discuss key matters with you, such as having someone else with you when you take the medication, avoiding taking it in public, sharing the medication with your family, receiving hospice care, and storing the medication in a secure location until you need it.

# **PIN 23-13-ASC THE LATEST GUIDANCE TO ASC LICENSEES ON SCREENING, TESTING, ISOLATION AND QUARANTINE, VISITATION, AND INFECTION CONTROL REQUIREMENTS.**

After the COVID-19 State of Emergency (SOE) expires on February 28, 2023, the California Department of Social Services (CDSS) is revising its guidance to licensees of ASC facilities regarding the pandemic. The California Department of Public Health (CDPH) terminated several State Public Health programs on March 3, 2023.

Officer Orders, including orders regarding masking and the COVID-19 vaccination and booster requirements for employees in ASC facilities, as well as updated recommendations for isolation and quarantine. COVID-19 vaccination coverage is high among workers in high-risk settings; however, CDSS and CDPH continue to recommend that all workers and high-risk individuals remain current on COVID-19, influenza, and other recommended vaccines, and to remain vigilant in preventing the spread of COVID-19 by maintaining some limited and temporary public health recommendations.

**Effective April 3, 2023, the State Public Health Officer Order, Adult Care Facilities and Direct Care Worker Vaccine Requirement, was terminated.**

As a result, there is no longer a COVID-19 vaccination and booster requirement for workers who provide services or work in ASC facilities. Licensees are no longer required to maintain records of workers' COVID-19 vaccination or exemption status. CCLD continues to encourage all facility staff to stay up to date with COVID-19 vaccinations and boosters as this remains the most important strategy to prevent serious illness and death from COVID-19.

# SO WHEN TO WEAR MASKS?

The CDPH advises all Californians to use masks:

- Should you have a cough, runny nose, or sore throat around others,
- Use a mask for 10 days after severe COVID-19 exposure.
- To wear a mask while testing positive for COVID-19, see to the CDPH Guidance for Isolation and Quarantine of the General Public.

Additionally, using a mask is crucial for persons at high risk of COVID-19 illness and as community transmission risk rises. Masks may be needed in certain situations:

In indoor public settings, such as hospitals, skilled nursing facilities, and long-term care facilities, elderly individuals or those at increased risk of serious illness may reside or receive treatment.

In congested indoor public spaces like public transit with limited ventilation.

# LEGISLATIVE UPDATES

Both the California State Senate and Assembly convened for an organizational session on December 5, 2022, to kick off the 2023-2024 legislation session. At this time, each house also formally elected their leadership. Senate Pro Tem Toni Atkins will continue to remain the leader of the Senate. In the Assembly, the Democratic Caucus met following the elections and determined that Assembly Speaker Rendon (termed out in 2024) will continue to serve as Speaker, but relinquish the position to Assembly Member Robert Rivas (Salinas) on June 30th, at the conclusion of the 2023-24 state budget deliberations.

With nearly a fourth of the Legislature being newly elected this year, we will see a number of new committee chairmanships and committee assignments. New members will face a challenging environment with the decline in expected state revenues and likely deficit. Additionally, the Governor has officially called a special session regarding oil and gas prices that started December 5th, but the Legislature will not start its deliberations until the new year.



# LEGISLATIVE UPDATES



With the Legislature reconvening in January, 6beds lobbyists will be pursuing legislation to allow 6beds members to expand the number of rooms they can rent in their facilities (depending on available space) as well as legislation to improve the process associated with referral agencies - transparency around the fees that they charge and information provided to prospective residents and their families.

## General Election Update

On November 8th, California held its General Election to vote on all state constitutional offices, all Assembly seats (80), and half (20) of the Senate seats. Although there is one race that is undergoing a recount, it appears that the overall makeup of the Legislature will not significantly change. The Legislature will continue with a Democratic supermajority - the Senate will include 32 Democrats and 8 Republicans, and the Assembly will include 62 Democrats and 18 Republicans. The ability of Democrats to hold on to a supermajority, with more than two-thirds of the seats in each house, allows them to determine the Legislature's priorities and positions on an array of the state budget, tax, and policy issues.

## **PIN 23-07-ASC - Updated Covid-19 Guidance On Vaccinations, Masking, Screening, Testing, Isolation And Quarantine, Visitation, And Infection Control Requirements**

- On April 3, 2023, the State Public Health Officer Order for Adult Care Facilities and Direct Care Workers Vaccine Requirement was terminated. Hence, COVID-19 vaccine and booster are no longer necessary for service providers or ASC staff.
- Licensees no longer need to keep records of workers' COVID-19 immunization or exemption status. CCLD urges facility workers to get COVID-19 immunizations and boosters, since this is the most effective way to avoid severe illness and death.

# PINs Update

## **PIN 23-09-ASC - End of Life Option Act Updates**

- The EOLOA permits a mentally competent adult who has been diagnosed with a terminal illness by their attending physician (and verified by a consulting physician) to seek a medication for the purpose of ending their own life.
- The EOLOA created a process for submitting these requests and mandates that all oral and written requests for a medication that aids in dying be accompanied by particular documentation in the patient's medical file.

## **PIN 23-12-ASC - Revised Infection Control Regulations And Permanent Adoption**

- This PIN focuses on definitions and terminologies and replacing the commonly used terms such as "communicable" to "contagious" in all sections. Other terms changed are found on the CDSS website under the PIN specified above.
- The licensee must update the Emergency Infection Control Plan and notify the Department within 15 days.

## **PIN 23-13-ASC - Updated COVID-19 Guidance On Vaccinations, Masking, Screening, Testing, Isolation And Quarantine, Visitation, And Infection Control Requirements**

- It details the end of vaccination and booster requirements for All Workers in Adult and Senior Care (ASC) Facilities, as well as the end of masking requirements. This PIN provides ASC licensees the latest guidelines for screening, testing, isolation, quarantine, visiting, and infection management.
- If staff test positive for COVID-19, licensees must follow the directions given in this PIN. Visitors, volunteers, and other individuals entering the facility are also subjected to passive screening methods.

## **PIN 23-14-ASC - Informational Call Regarding Infection Control, Emergency Preparedness, And Post-Pandemic Updates**

- Elderly, and chronically ill individuals are more susceptible to heat stress. Prevention (drinking, refreshing) is preferable than treatment.
- Some of the few highly recommended tips are to, stay in an air-conditioned place, wear light, loose clothes, and apply sunscreen with SPF 15 or higher 30 minutes before going out. Reapply sunscreen as directed on the packaging.

3. **Local Health Departments (LHDs).** LHDs may have information available about locations where COVID-19 vaccine is available in the local community. Please check your LHD's <https://www.cdph.ca.gov/Pages/LocalHealthServicesAndOffices.aspx> website for vaccine information.
