Advocacy Day Recording





The California Legislature is in its second year of a 2-year session. Senate and Assembly bills that are still viable must be in the other house i.e. Assembly bills must have passed the Assembly and now be scheduled for a hearing in the Senate and vice versa. Policy committees must hear and report all bills prior to the Legislature's summer recess beginning on July 3rd. The Legislature returns from break on August 5th and has until August 16th to send bills to the floor of the Senate/Assembly for a vote by the entire house (Senate or Assembly). The Legislature adjourns for the year on August 31st.

There are literally more than 1,000 bills still under consideration. Here are the 5 priority bills that 6beds lobbyists and board members have actively engaged on -

SUPPORT: AB 1993 (Kalra)—Residential care facilities for the elderly: maximum number of residents. Expands from six to 8 the number of residents that can reside in an RCFE without having to get a conditional use permit. Will be amended to incorporate the DSS regulation limiting the number of residents to 2 per bedroom. The bill is cosponsored by 6beds and the California Commission on Aging. It passed unanimously out of the Assembly Human Services Committee and off of the Assembly floor with a vote of 65-2. The bill will be heard next in the Senate Human Services Committee – not yet scheduled.

LEGISLATIVE UPDATES

OPPOSE: AB 1911 (Reyes)—Residential care facilities: complaints. This bill sets statutory deadlines for DSS to act on complaints and report status to complainants. So far, no problem. But it also gives the complainants the right to appeal. We are concerned that the Department, already short of staff to perform their existing functions, will get bogged down even more if they have to handle these appeals. We are opposing the bill unless the bill is amended to remove the complainant's right to appeal. The bill will be heard next on June 17th in the Senate Human Services Committee.

OPPOSE: SB 1406 (Allen)—Residential care facilities for the elderly: resident services. This bill imposes a cap on how much RCFE fees can be raised from year to year. Right now, the formula in the bill is 5% plus the consumer price index. There is discussion around a one half of the labor index increase. There is an exemption for changes in level of care. The bill also gives residents the right to refuse service and requires RCFEs to honor the request. 6beds is opposing the bill on the grounds that RCFE costs are not in our control and tend to rise faster than the CPI, so that an apartment rent control model does not work. We also oppose the right to refuse service, which could jeopardize the safety of the resident refusing service and other residents and staff. 6Beds lobbyists have been in frequent negotiations with the author, his staff, the bill sponsors and senior representatives of the Department of Social Services. The bill will be heard next in the Assembly Committee on Aging and Long-Term Care on June 18th.

OPPOSE

LEGISLATIVE UPDATES

OPPOSE: AB 2773 (Kalra)--Elders and dependent adults: abuse or neglect. This bill would lower the burden of proof for finding liability for elder abuse, limited to situations when the licensee has engaged in willful destruction of evidence ("spoliation"). This bill is sponsored by the Consumer Attorneys and is identical to a bill (AB 859) (Laird)) we opposed in 2017 that was vetoed by Gov. Jerry Brown. 6beds is opposed on the grounds that it would attract more lawsuits with settlement demands, further driving up insurance costs. 6beds has enjoyed a very positive longstanding relationship with Assemblymember Kalra (he is the author of our bed expansion bill), and we will continue to work with him and his staff with the hopes of resolving 6beds concerns with the bill. The bill will be heard next in the Senate Judiciary Committee - not yet scheduled.

SUPPORT: SB 875 (Glazer) - Residential care facilities for the elderly - referral agencies. This bill would require the licensure of agencies that refer consumers to residential care facilities for the elderly by the Department of Social Services. The bill would require new disclosures, background checks for licensee representatives, cessation of contact and data sharing once requested. The bill is co-sponsored by ActEight and A Place for Mom. 6beds lobbyists have been in frequent ongoing negotiations with the author, sponsors and opposition to the bill with the goal to amend the bill in such a way to provide strong meaningful protections for families and potential residents as well as transparency and protections for 6beds members. SB 875 is the 6th attempt by the Legislature to regulate the referral agency industry, beginning as far back as 2015. The bill is scheduled to be heard next on June 11th in the Assembly Human Services Committee.

Provider Information Notices (PINs) Updates for Adult and Senior Care (ASC) Program

<u>PIN 24-06-CCLD</u> - Use Of The Everbridge Emergency Notification System To Notify Licensees And Providers Of Disasters And Emergencies

- The Community Care Licensing Division (CCLD) will continue to use the Everbridge Emergency Notification System to alert licensed facilities about disasters and emergencies such as wildfires, earthquakes, and extreme weather events. Notifications will be sent via text or email, and there are two types: those requesting a response about your facility's operational status, particularly during evacuation events, and those that are strictly informational.
- For notifications requiring a response, licensees have one hour to reply with their facility's status using text, email, or phone. If no response is received, the local Regional Office (RO) will follow up directly. Facilities should ensure their contact information is current with the RO and regularly review and update their Emergency Disaster Plans to remain compliant and prepared.

<u>PIN 24-04-ASC</u> - (Supersedes PIN 24-01-ASC)Updated Guidance On Respiratory Viruses Including COVID-19, Influenza, And Respiratory Syncytial Virus (RSV)

- The California Department of Social Services (CDSS) is updating its guidance to move away from a COVID-19-specific framework, aligning with broader respiratory virus recommendations from the California Department of Public Health (CDPH). This update reflects the reduced impact of COVID-19 due to widespread immunity and available treatments. The new guidance includes updated masking protocols and the removal of COVID-19-specific screening, isolation, testing, and visitation procedures.
- Licensees must continue following the California Occupational Safety and Health Administration (Cal/OSHA) COVID-19 Prevention Regulations and maintain their ASC Infection Control Plans according to updated CDPH recommendations. Facilities are advised to reconcile differing guidance from various health authorities by adhering to the strictest requirements and updating their infection control measures accordingly, particularly in preparation for any declared emergencies.

AB 1993 KALRA STATUS: PASSED

"As a result of a limited supply of housing coupled with the rising cost of living, more and more California families are being displaced or forced into financial hardship. While we have made some progress to address our state's housing crisis, there is still much to be done to ensure people can afford to live in the communities where they work," said

Assemblymember Kalra. "This is why I have put forth these four bills that collectively will protect renters, increase housing availability, and support the most vulnerable and disadvantaged in our state. I am thankful for my Assembly colleagues' support and look forward to continuing the work in the Senate."

AB 1993 allows Residential Care Facilities for the Elderly (RCFE) homes to serve up to eight individuals which will unlock homes for thousands of residents, providing both housing and care for the state's aging population. Older adults are the fastest-growing population of unhoused persons in California and those who require assistance with daily activities have an exceptionally hard time finding accommodations. The bill will help older adults remain in their communities and in proximity to their loved ones while receiving the 24-hour non-medical care they need.
